Assessment Strategies For Each Element Of Assessment	Summative assessment (equivalent to 4500 words +/- 10%) will be a written assignment (essay) that addresses all unit learning outcomes, and structured to meet assessment criteria. The student is required to produce a written assignment. They identify an issue or topic that is current in their practice area. With reference to relevant reading (practice-focused and theoretical) they explain the development (or passing) of this issue or topic in their disciplinary area. In doing this, they will explore and explain how this particular issue or topic became significant or, conversely, why it is in decline. In doing this, students will discuss the 'bigger picture' of their practice area, for instance cultural, political, economic, or policy contexts or factors. Where appropriate, and with an eye to contemporary developments, students will include some discussion on the role of the patient as 'consumer' or 'stakeholder' in their practice setting.

Outline Of The Unit

Brief Summary	This unit provides the candidate with an opportunity to explore and discuss contemporary policy contexts and in doing so encourages them to take the 'long view' in respect of a selected practice area.
	The candidate is encouraged to select a single issue or topic that is current in their chosen area or field, and to discuss how and why this issue has become prevalent (or is in decline) in respect of policy and political positions.

Indicative Content

Key point seminars/workshops will be delivered to include:

- 1. Health/social care economics
- 2. The history of the National Health Service
- 3. Political/ideological perspectives
- 4. The role of stakeholders/consumers in the public sector
- 5. Policy/concept analysis frameworks
- 6. Current policy and/or political debate

Key skills of literature searching and reviewing will also be included according to student self-assessment.
